## Enhanced Placement Program – Background

The Enhanced Placement program (EP) is a city-funded effort that started in 1999 by **Philadelphia Connections**. Through the EP program, Philadelphia Connections provides additional training and educational opportunities to ensure that students are better prepared to work with individuals receiving services in the public behavioral health system, and their families.

The EP program is also aimed at encouraging students to consider taking jobs within community behavioral health agencies after graduation. The Philadelphia Connections program also provides funding and support to schools, public behavioral health care provider agencies, and other projects with a goal to enhance field placement or internship experiences for students planning to work in the behavioral health field.

## **Qualifying for the Enhanced Placement Program**

- You are a student who is enrolled in a graduate program for social work (or 4<sup>th</sup> years BSW), psychology, counseling, or other program that specializes in behavioral health.
- You are in or about to enter a fieldwork placement at a behavioral health provider or a site which works with individuals who have behavioral health needs.
- You have informed your university field director and/or field instructor that you would like to participate and they have agreed to your participation.
- You have read the student packet and understand the contents within it, what is expected of you as a student, and agree to the policies and procedures.

## **Enhanced Placement Program Benefits**

 Each EP student (if interning at a CBH funded agency) receives a stipend of \$500.00 per school year (4<sup>th</sup> year BSW students receive \$300), as an incentive for being involved in the EP program and to cover any expenses associated with attending EP functions.

- 2. All EP students are provided with five days of seminars on content commonly needed in their field placements or internships, as well as a career day.
- 3. Other presentations and workshops, which are not required, are offered to EP students throughout the year, free of charge.
- 4. Additional enhancements to the EP students' placements may be negotiated by Connections with each school-agency partnership.
- 5. As a benefit to field supervisors of EP students, Connections offers a free seminar series which provides low cost CEU credits.
- 6. Alumni of the EP program are also invited to these ongoing educational programs, and to be a part of the Philadelphia Connections Alumni Association (PCAA).

## Stipends

#### In order to receive the stipend, you must:

- 1. Be matriculated in a graduate program for social work, counseling, psychology or other program that specializes in behavioral healthcare OR be in the 4<sup>th</sup> year of an undergraduate social work program.
- 2. Be enrolled for a field placement/internship at a Community Behavioral Health (CBH) funded agency.
- 3. You must participate in all classes to receive the full stipend.
- 4. It is expected that you will participate in the end of year career day.
- 5. You must participate in all testing and survey's regarding the program which assists in improving the quality of the program.
- 6. You must complete and return a Connections Invoice form as directed below:

#### First Semester:

Fill out an invoice your first day of EP classes.

Fill out an invoice at <u>your final day of EP classes</u>. You must send in your invoice by April 21<sup>st</sup> to be assured of receiving the second stipend payment.

The invoices take up to eight weeks to process <u>after</u> we receive them, so you may not get a check for up to <u>eight weeks</u> after your invoice arrives at Connections.

**Graduate EP students will receive a stipend of \$500** (disbursed in two payments of \$250). **Fourth-year BSW EP students will receive a stipend of \$300** (disbursed in two payments \$150).

## **EP Enhancement Seminars**

- Family and Consumer Perspectives
- Philadelphia Department of Behavioral Health and Intellectual disAbility Services (DBHIDS)
- Psychopharmacology, Recovery & Ethics
- Suicide Assessment and Intervention
- Career Panel & Career Day

## **EP Structure**

Each student will be assigned to a cohort. <u>You will be told which group you are in as soon as you are accepted to the EP program.</u> If you have a preference for a certain group and set of dates, please contact us to make this known to us as soon as possible. Seminars are held on Mondays and

Fridays. Two topics are covered in one day. Although two cohorts are scheduled for the same time, they will usually meet separately.

#### **Monday Groups**

Groups 1&2, 3&4, and 5&6 will meet throughout the entire school year

#### Friday Groups

The Friday I Group will meet mostly in the fall semester; the Friday II will meet mostly in the spring semester.

#### **Group Size**

Groups are generally made up of fifteen students or less to allow for maximum discussion and interaction with seminar presenters. However, class size may vary dependent upon student need for certain dates, or days.

#### Lunches

Lunch will be served free of charge. <u>\*Unfortunately we are unable to accommodate special dietary</u> <u>needs at this time as lunches must be ordered prior to the finalization of our EP enrollment process. We</u> <u>suggest you prepare accordingly.</u>

#### **Testing and Surveys**

Testing and surveys are used by Connections to determine the effectiveness of the seminars, and the effectiveness of our program. They are not related to grades from your school or agency evaluations, however your participation is required in order for you to receive a stipend.

You will be asked to complete the following:

- 1.) A pre-test before each seminar
- 2.) A post-test after each seminar
- 3.) Presenter feedback
- 4.) At the end of the first semester, feedback regarding your experience with your field placement.
- 5.) At the end of the second semester, feedback regarding your experience with your field placement, your experience with EP program, and demographic information.

Testing and surveys will be sent to you via your email. When applying to the EP program, please use an email that you will be able to utilize regularly, and will allow you the flexibility to complete testing and surveys at your convenience. (Example, emails from your internship may not be accessible when you are not physically in the building, or may have restrictions).

If you have trouble accessing the testing, or have an inability to complete testing online, please contact us immediately so that we can troubleshoot.

Pretesting will close the morning of your seminar, and you will not be able to complete them after that time. If for some reason you are unable to complete your pretest, please make us aware.

Post testing will close 30 days after you've completed the seminar, however we suggest you take it soon after you receive it, as your retention will be better when the material is fresher in your mind.

#### Tardiness

Lateness, though at times unavoidable, is a disruption to not only the presenter, but the class as a whole. As a professional in the field, we ask you to be mindful of how your lateness will affect others, and to plan accordingly in order to avoid this disruption. If you know that you will be late, please contact EP Office Manager, Ms. Green, as soon as possible.

#### **Use of Phones**

Being present while others are speaking will be an important skill while in the field. We ask that you put your phone on silent, and use it only during breaks or in the case of an emergency. <u>Please do not surf the internet, social media, or text on your phone while in class</u>. Being in the moment, and giving the speaker your undivided attention is an act of common courtesy. Please pay the seminar speaker the same courtesy you would like if you were speaking.

#### **Student Conduct**

We believe that the students that join us for the EP program are indeed the best and the brightest who proudly represent their universities, their provider agencies, and their future professions. With this in mind, we request that students remain respectful in their interactions with the presenters and one another. Class should be a time for respectful dialogue, and fruitful discussion. We highly recommend having a familiarity with your universities code of conduct, as well as your future professions code of ethics. What is expected of you in those documents is also what is expected of you within the EP program.
